Standard music video formats not to exceed 12 minutes in length. Music must be in the Surf, Rockabilly, Swing, Psychobilly, Cow Punk, Lounge, Crime Jazz, Be-Bop Jazz, Alternative Country or Punk Genres.

SHORT (2–65 Minutes)

Films in the B-Movie, Campy Horror, Zombie, Alien, Monster, Hot Rod, Rat Rod, Kustom Kulture, Surf, Exploitation, Car Chase, Biker, Beatnik and Sci-Fi styles.

NARRATIVE FEATURE (65–120 Minutes)

Films in the B-Movie, Campy Horror, Zombie, Alien, Monster, Hot Rod, Rat Rod, Kustom Kulture, Surf, Exploitation, Car Chase, Biker, Beatnik and Sci-Fi styles.

DOCUMENTARY

Must contain Kustom Kulture subject matter- including Pin-Ups, Burlesque Dancing, Hot Rods, Rat Rods, Kustom Cars, Pin Stripping, Lo-Brow Art, Tattoo Art, Greaser Culture, Rockabilly, Psychobilly, Choppers, Fabricators, Car Shows, etc.
